

## CASH NOW Mailbox Rental Terms and Conditions

1. Packages and parcels accepted by Cash Now Pty Ltd are subject to refusal for shipment by the carrier and will be returned to the Customer. If a parcel is refused by carrier, transportation charges will be refunded to customer. Packaging charges for services performed by Cash Now Pty Ltd are non-refundable once completed.
2. All articles other than "Express Mail" and "Registered Mail" tendered to Australia Post on Customers Behalf are not insured, not tracked via computerised systems and are assumed to have no commercial value.
3. Cash Now Pty Ltd does not accept illegal items or hazardous materials. Customer states "This shipment contains no explosives, corrosives, compressed gases, contraband, hazardous materials, or other items that are injurious, contaminate or of illegal content. All contents are shipped in full compliance and in the absence of fraud.
4. Customer acknowledges the role of Cash Now Pty Ltd as a service reseller for carriers. Customer agrees that service is furnished, payment earned and Cash Now Pty Ltd's duty to its customer is fully discharged upon tender of customer's shipment to carrier. Customer agrees that after shipment is tendered to carrier all charges are non-refundable. Consignee's refusal for delivery, failure to accept delivery, failure to claim items beyond the control of undeliverable or incorrect address furnished by the Customer's are items beyond the control of Cash Now Pty Ltd. Customer will not receive any refund under such circumstances.
5. Cash Now Pty Ltd offers no warranties either written or oral and Cash Now Pty Ltd is not liable for Carrier's failure to make timely delivery on delivery date specified. Any statements by Cash Now Pty Ltd as to probable date of delivery by Carrier is a statement of opinion and estimate only and is not liable for any consequential, incidental, or punitive damages, nor any loss or damage resulting from delays in shipping or delivery.
6. Cash Now Pty Ltd shall not be liable for the carrier to properly collect or remit funds for the COD parcels. If Recipient's cheque is accepted for COD's by the carrier, it will be at your own risk unless "Cash Only" is noted on COD tag. You acknowledge that you have read and understand the instructions on the COD tag.
7. Following shipment, customer agrees to pay any additional charges by carrier to Cash Now Pty Ltd for corrections of address, weight, duties, customs clearance, taxes or any other such additional charges. All such charges may be charged to Customer's credit card without further notification. This contract shall serve for all purposes as a "signed sales draft".
8. Trading hours of business for collection of mail is 8am to 6pm Mon-Fri. Subject to change without prior notice.
9. Initial setup fee totals \$25.00 and is inclusive of ONE key. Any additional keys required **must** be ordered through Cash Now Pty Ltd. The cost of each additional key will be set at \$10.00 per key. This \$10.00 is fully refundable at the end of your contract with Cash Now Pty Ltd.
10. Mail Forwarding is available at a cost of \$5.00 per month plus postage charges up to 10 items per month. Any additional forwarding after the set 10 items per month limit will be charged of 50c per additional item.
11. Mail alerts are available to clients via SMS to advise when mail is received at a cost of \$5 per month. Cash Now Pty Ltd is not responsible if messages are not received.
